Legal Aid was sent in over two weeks ago as previously advised. If they have not received / processed the form that is outside my control. Clearly you are not familiar with the workings of the Legal Aid Agency and the frequency with which they lose forms, or the amount of time I waste on the phone to them making enquiries about legal aid applications previously sent in.

The Crown Court has been advised during a telephone conversation that the appeal would be 2- 3 days as per the length the original hearing took.

As previously advised Lorraine all other work will be undertaken once legal aid has been granted otherwise, we will not get paid for any backdated work. I submitted the appeal and that has been lodged. I did not submit a court stamped form so will now have to get fresh form signed and date stamped and I will only be paid from that date.

Please indicate if Simon can attend my office on Friday 9th October 2015 at 2pm with a full list of any new evidence he wants included in the appeal hearing.

In the intervening period of time I will get a crm 14 date stamped.
